Speaker Biographies

Debra A. Antoon, BPharm, CPh



Debra Ann is currently serving as the Corporate Manager of Ambulatory Pharmacy Services at Martin Health System in Stuart, Florida. Her practice encompasses 8 Primary Care Offices serving 42 Physicians and Mid-Level Providers across two counties. Her staff of 2.2 pharmacists conducts in depth, face to face patient visits in the individual Physician offices, collaborating elbow to elbow with the providers. This patient panel consists mainly of complex chronic disease patients referred by these Physicians and Mid-Level Providers. Prior to her current role she has served as Pharmacy clinical staff, supervisor and operations manager at Martin Health over the last 25 years. She also was a trained Nuclear Pharmacist, has had experience in retail settings, and as Florida Consultant Pharmacist. She is a speaker for NOVA Southeastern Pharmacy CE programs. She is a member of ASHP, FSHP, ACCP and FPA. Debra Ann is an active Volunteer in her community and is Chapter Coordinator for a local Project Linus Non Profit Agency. She received the Pinnacle Award for Outstanding Clinical Achievement in 2013 and the Leader of the Quarter Award 4th Quarter 2015 awarded by Martin Health System. Debra Ann graduated from Massachusetts College of Pharmacy in December 1980 and received her Nuclear Pharmacy Degree in 2001. Debra Ann earned a Certificate in Patient Care Skills from the Canadian Pharmaceutical Association's ADAPT Program in 2013.



Dave L. Dixon, Pharm.D, BCPS, CDE, CLS, AACC, FNLA

Dr. Dixon is an Assistant Professor in Ambulatory Care at VCU School of Pharmacy. His practice sites include a university-based outpatient cardiology clinic and local free clinic where he practices collaboratively with physicians to manage cardiometabolic disease and heart failure. Dr. Dixon has also co-led the medical team for several large community outreach events throughout the Commonwealth of Virginia. Prior to joining the faculty at VCU, Dr. Dixon was a Clinical Pharmacist Practitioner at Wake Forest Baptist Medical Center. In addition to anticoagulation and lipid clinic, he co-developed an antiarrhythmic monitoring clinic and diabetes program for health-system employees. Dr. Dixon is a Fellow of the National Lipid Association, Diplomate of the Accreditation Council for Clinical Lipidology, and Associate of the American College of Cardiology. Dr. Dixon is currently serving a three-year term on the Southeast Lipid Association Board of Directors. He also serves on the Editorial Board for the Journal of Clinical Lipidology. Dr. Dixon received a 2015 AACP New Investigator Award, 2014 AACP Innovations in Teaching Award, and an Outstanding Preceptor Award from the VCU Pharm.D class of 2013.



Sharon S. Gatewood, PharmD, FAPhA

Dr. Gatewood is an Associate Professor in the Department of Pharmacotherapy and Outcomes Science at Virginia Commonwealth University (VCU) School of Pharmacy. She has worked with Martin's Pharmacy since 2006 to develop enhanced patient care programs in Richmond, VA. She is also currently working with health disparities to improve patient outcomes in a Federally Qualified Healthcare Center, Daily Planet. Dr. Gatewood received her Pharm.D. from VCU in 2002 and completed a Community Pharmacy Residency at VCU in 2003. She currently serves on the Editorial Advisory Board for Journal of American Pharmacist Association and a member of the ACPE Experiential Education Taskforce for APhA. In 2002, Dr. Gatewood received the Community Pharmacy Achievement Award and the 2011 Outstanding Mentor Award from Virginia Commonwealth University School of Pharmacy, in 2003 and 2010 the American Pharmacist Association (APhA) Academy of Pharmacy Practice and Management Presentation Merit Award, and in 2010 the Distinguished Young Pharmacist award from Virginia Pharmacist Association. Also in 2013, she was awarded the APhA Community Pharmacy Residency Excellence in Precepting Award and VPhA Ed D. Spearbeck Virginia Pharmacist Service Award. Most recently she has been awarded Fellow of APhA Academy of Pharmacy Practice and Management in 2015.

David A. Holdford RPh, MS, PhD, FAPhA

David Holdford is a Professor in the Department of Pharmacotherapy and Outcomes Science at the Virginia Commonwealth University School of Pharmacy. His research includes assessing the impact of innovative pharmacist services on medication use and the economics of pharmaceuticals and services on health outcomes. In addition, he has published extensively on the marketing of pharmacist services. Recent published and presented research includes measuring the economic burden of health events such as opioid poisoning and food allergies, the effect Appointment Based Medication Synchronization on medication adherence, and modeling the cost effectiveness of naloxone autoinjector for lay opioid overdose reversal.



Leticia R. Moczygemba, PharmD, PhD

Dr. Moczygemba is an Associate Professor, Department of Pharmacotherapy and Outcomes Science, School of Pharmacy, Virginia Commonwealth University (VCU). She performs practice-based research with practitioners and health systems, with a focus on development, implementation, and evaluation of care models, to transform health care delivery. Her research has been funded by the NIH, CMS Innovation Center, HRSA, United States Pharmacopeia and the American Society of Health-System Pharmacists Foundation. Dr. Moczygemba is currently a VCU Blick Scholar. She serves on the American Pharmacists Association Medication Therapy

Management Evidence Advisory Panel and on the editorial boards for the Journal of the American Pharmacists Association and Research in Social and Administrative Pharmacy. She also received the 2008 University of Texas College of Pharmacy Distinguished Young Alumnus Award and was a NIH KL2 Scholar from 2010 – 2013. She received her PharmD and PhD from The University of Texas in 2004 and 2008, respectively.



Evan Sisson, Pharm.D., MHA, CDE, FADE

Dr. Sisson is an Associate Professor at VCU School of Pharmacy in Richmond, VA. His current practice site is an inner-city free clinic where he practices in a physician-pharmacist model to manage drug therapy under a collaborative practice agreement with the medical director. This makes him well suited to conduct the fidelity assessments for the proposed study. Prior to joining the faculty at VCU, Dr. Sisson worked in the interdisciplinary diabetes and lipid clinics at the Richmond Veterans Affairs Medical Center. Dr. Sisson is a frequent author on the topics of drug therapy for dyslipidemia and diabetes. Two recent book chapters include *Pharmacotherapy for Glucose Management* and *Pharmacotherapy: Dyslipidemia and Hypertension in Persons with Diabetes* in the 3rd edition of AADE's Art and Science of Diabetes Self-management Education. Additionally, he authored the 5th edition of *AADE's Quick Guide to Medications*. Dr. Sisson is an active volunteer. He is a past member of the AADE Board of Directors and the National Health Council's Advisory Board on Patient-Centered Care. Currently Dr. Sisson serves as Chairman of the Board of Directors for the Center for High Blood Pressure in Richmond, VA.
